The fifth meeting of the ANREP Executive Council for 2001 convened at 5:00 pm in Naples Florida, November 14, 2001.

#### ITEM 1 – ANREP conference planning

##### 1. Revenue sharing with Florida

Executive board agreed that ANREP would provide Joe Schafer (ANREP 3<sup>rd</sup> National conference organizer) a budget for hiring entertainment for the conference social, to encourage membership participation, if no local sponsorship can be obtained.

##### 2. Conference Exhibitors

Contacting appropriate exhibitors for the conference was discussed. Board members volunteered to contact other professional organizations for exhibitor lists, including SAF (Bill Hubbard), The Wildlife Society (Joe Schafer), and the Society for Range Mgt (Chuck Gay).

Executive Board agreed to pull together vendor and exhibitor names and addresses for use in future ANREP conferences. This would provide a significant source of revenue for ANREP. Joe offered the services of University of Florida to organize a vendor database/ mailing list.

It was suggested that ANREP offer JCEP associations a booth for the conference.

#### ITEM 2 – PILD and JCEP

##### 3. ANREP membership involvement

There was concern expressed by **Bill Hubbard** regarding the lack of ANREP involvement in the **JCEP Regional Leadership Workshop Planning. The JCEP Regional Workshops need ANREP representatives in order to show our good faith involvement with the other JCEP association partners.**

**Both Mike Kroenke and Joe Schaffer are serving as the ANREP Reps. for the PILD Conference in Washington DC for April 28-May 1. Mike was involved with the PILD Conference Planning at the conference site in October, 2001. ANREP Board members and ANREP members are encouraged to attend this workshop.** Ways to encourage membership participation **including some registration compensation** was discussed during the strategic planning session earlier in the week. This issue was identified as a particularly important one that is currently being addressed by the Board.

### ITEM 3 – Galaxy Conference update

Chuck Gay updated the Board on the conference planning for Galaxy II, Sept. 21-23, 2003. All event locations will be centered around the Salt Palace. Each participating Association will have a central location in one of the 4 hotels in the vicinity, for convenience.

The tours and events that are being discussed by the Galaxy planning committee sound very fun and family friendly, including the Utah symphony

Chuck also promises that no ANREP presentations will be scheduled during any of the tours (apparently this has been a problem during past conferences). The Board commended Chuck and Nancy Mesner (also from Utah State) for their great work on the Galaxy II planning committee. It sounds like it's shaping up into a great conference.

Meeting was adjourned at 6:00 PM. The next Executive Board meeting will be held January 25 2002, via conference call.
