4. Reports from Officers, Initiatives, and Current Conference Committee

- 2021 Conference Update – Shannon Murray
 - Shannon presented a draft schedule for the conference.
 - For the concurrent sessions, the presentations will be pre-recorded, and participants will view these in advance and the live portion will be a quick recap and Q&A.
 - Shannon presented the current draft budget.
 - \$150 registration fee should cover costs and may be able to go lower with ANREP's \$6,000 contribution to the budget.
 - A motion passed to set a \$35 student rate that will come with a free 2021 membership.
- Executive Secretary's Report – Dean Solomon
 - Dues notices went out this week.
 - We need to look into alternative services or upgrades to our online member services and website. An ad hoc committee comprising Kris, Alicia, Dean, and Chad will look into this and make a recommendation to the board.

 - Focus groups are done and results are being analyzed.
 - A motion passes to propose having the ANREP past president serve as an ex-officio ANREP rep for NREEF board of trustees.
- Regional Rep Updates

 - Lara mailed out 2020 awards.
 - The committee is setting up things for the next round of awards.
- 2022 Conference
 - We need to prepare to start drawing up contracts, starting with MSU.
- JOE update
 - JOE is transitioning to a new editorial structure, as Clemson University Press has taken over management of the journal.
 - There is a call for volunteer associate editors on the JOE website—regional reps will send this link out in the next update.
- Nominations
 - Lara will send an email to the membership announcing the newly elected officers

- Executive secretary agreement has been finalized.
